

**CITY OF HARAHAH
PIGGY-BACK EMERGENCY CLEANING OF DRAIN LINES
CONTRACT AGREEMENT**

Amended

THIS CONTRACT AGREEMENT ("Contract") is made and entered into as of the 11 day of July, 2015 (the "Effective Date"), by and between Compliance Enviro System, LLC., ("Contracting Party"), and the City of Harahan (the "City").

WHEREAS, on or about June 11, 2015, the City of Harahan was granted approval to utilize Jefferson Parish's Contract #55-14359, for Emergency Cleaning of Drain Lines by the Jefferson Parish Council. The City of Harahan will piggy-back on to this Jefferson Parish contract. Attached hereto as Appendix A and incorporated herein by reference ("Request to Utilize Jefferson Parish's Contract #55-14359").

WHEREAS, on December 12, 2001 a resolution was declared to be adopted ("Resolution No. 95189") granting authorization to any local Public Procurement Unit within the State of Louisiana, to purchase materials and services, as needed under the Jefferson Parish approved contracts and blanket purchase orders, attached hereto as Appendix B and incorporated herein by reference ("Resolution No. 95189").

WHEREAS, on April 30, 2014, a resolution was declared to be adopted ("Resolution No.122738") accepting the lowest responsible bid of Compliance Enviro Systems, LLC., ("CES") for services in connection with the Jefferson Parish Department of Public Works contract for Emergency Cleaning of Drain Lines, attached hereto as Appendix C and incorporated herein by reference ("Resolution No.122738").

WHEREAS, the City and Contracting Party wish for Contracting Party to continue to supply materials and/or provide work directly for the benefit of the City pursuant to the *unit prices* of Contracting Party's work furnished to the City and attached hereto as Appendix D and incorporated herein by reference ("Bid 50-109306 Bid Documents and Specifications").


NOW, THEREFORE, for and in consideration of the above premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contracting Party do hereby agree as follows:

1. The City shall compensate Contracting Party for the work Contracting Party performs for the task ordered work in accordance with the City of Harahan and Appendix C.

2. The term of this contract shall be for one (1) year from the effective date with an option for one (1) year renewal by mutual agreement.


