## Contract Agreement Between Louisiana Charter / Harahan Horseshoe Pitchers Association and the City of Harahan

In the interest of providing mutual benefits to both the City of Harahan and Louisiana Charter / Harahan Horseshoe Pitchers Association, this agreement is made and entered into by and between the City of Harahan and Harahan Horseshoe Pitchers Association.

The City of Harahan will provide recreational space at the Horseshoe Pit for Harahan Horseshoe Pitchers Association for a weekly league. In return, the City of Harahan will receive fifty dollars (\$50.00) per week, excluding rain-outs as deemed by Recreation Director / Administration. Fee will be paid weekly, at which time keys to court area, bathroom, and light panel lock will be issued to the Harahan Horseshoe Pitchers Association Representative. At the end of league play, all lights will be turned off and light panel is to be re-locked. All keys will be returned the following morning.

The field will be used at mutually agreeable dates and times. Harahan Horseshoe Pitchers Association will have access and use of the Horseshoe Pit once a week on Thursdays from 6:00 pm to 10:00 pm beginning March 1<sup>st</sup>, 2018 through November 15<sup>th</sup>, 2018.

Harahan Horseshoe Pitchers Association Members will be allowed to bring water, tea, soft drinks within the court area. No alcohol beverages to be consumed on the property at any time.

All trash generated by the Harahan Horseshoe Pitchers Association will be placed in containers provided by the playground.

Harahan Horseshoe Pitchers Association is open to participation by any Harahan resident or other person.

No fundraising events are to be held on the City of Harahan's property.

Harahan Horseshoe Pitchers Association agrees to defend, protect, indemnify and hold harmless the City of Harahan, its employees, agents and assigns, from any and all claims arising from Harahan Horseshoe Pitchers Association's negligence or fault, or that of its agents, family members, officers, volunteers, helpers, partners, organizational members, associates, corporations, invitees or guests, arising out of the use of the City's property.

Harahan Horseshoe Pitchers Association will maintain participation with the Louisiana State Horseshoe Pitchers Association and will provide updated Insurance Certificates annually.

Harahan Horseshoe Pitchers Association has provided, and during the term of his Contract will continue to provide, a certificate of insurance to the City of Harahan, which provides evidence of general liability coverage of not less than \$1,000,000.00 per occurrence. Harahan Horseshoe Pitchers Association also agrees to have the City of Harahan named as "Additional Insured" on the foregoing general liability policy for the dates of usage of City property for any and all claims which may arise out of Harahan Horseshoe Pitchers Association's operations or which are brought against the City of Harahan by Harahan Horseshoe Pitchers Association, its employees, agents, partners, family members, students, customers, Function attendees, guests, invitees, organizational members or associates. Harahan Horseshoe Pitchers Association also agrees to ensure that its liability insurance policy will be primary in the event of a covered claim or cause of action against the City of Harahan. The aforementioned general liability policy must be endorsed if and as necessary to meet foregoing requirements of endorsement and the policy's being primary in nature.

This agreement was read and signed on the 9<sup>th</sup> day of March, 2018 for a term of one year.
